Report Overview

CEO Scholar Eligibility Requirements

- Students must reside in Bridgeport, Hartford or New Haven.
- Family household income cannot exceed 200 percent of the federal poverty guidelines.
- CEO families may choose any private accredited K-8 school in Connecticut.
- CEO provides half of the private school tuition to a maximum of \$2,100/year parents provide the balance.
- Students may enter CEO grades K-5 and will be may be eligible to continue their scholarship until grade 8.

Measures Used to Evaluate Performance Comparisons


- Comparisons between CEO Scholars <u>and</u> their public school peers:
 - Standardized tests in grades 3 through 8 in English Language Arts (ELA) and Math
 - o CEO Scholars' school grades in ELA and Math are measured (public school comparisons not available)
 - o CEO Scholars and their public school peers are tested in grades 3 through 8 for greater comparability.


Results

- CEO Scholars have higher achievement than their public school counterparts overall.
- CEO Scholars have significantly higher average achievement than their public school peers deemed "high needs."
- "High Needs" students come from low-income families, are English learners, or have disabilities.
- All CEO Scholars would be considered "high needs" if they attended public schools.

Combined CEO Scholars & Public School Students, Achievement Rates Compared

- Nine out of 10 CEO Scholars take standardized tests that report results as national percentile ranks (NPR).
- Percentiles range from the 1st to the 99th percentile, with the average set at the 50th percentile.
- Thus 55 means that students scored better than 55 percent of all test-takers nationwide.
- Public school students in Connecticut take the Smarter Balanced assessment.
- Scores represent achievement levels ranging from 1 (standard not met) to 4 (exceeded standard).
- The public school scores below represent combined percentages of students scoring at Levels 3 (met standard) and 4 (exceeded standard).
- Thus 42 means that 42 percent of students scored at or above the grade-level subject standard.







- Combined average per-pupil spending by Bridgeport, Hartford, and New Haven public schools is almost three times higher than the combined average tuition of private schools enrolling CEO Scholars in those same cities.
- CEO Scholars significantly outperform their public school peers, particularly high needs students from disadvantaged socio-economic backgrounds.
- CEO Scholars outperform their public school peers in both subjects across all grade levels with one exception:
 - Public school fourth graders (all) slightly exceed their CEO peers' performance in math, 39 percent average achievement compared to 33 percent.
- Public school fifth graders' math achievement is two-thirds lower than their CEO peers, all of whom would be considered high needs students.
- Close to two-thirds of CEO Scholars in grade 8 are achieving in ELA and math.
- A majority of their public school peers are not achieving in these core subjects in grade 8.
- Such results suggest that CEO Scholars have a much more solid foundation as they head off to high school, which helps increase the likelihood that they will graduate rather than drop out.



Bridgeport CEO Scholars & Public School Students, Achievement Rates Compared

- The performance of Bridgeport CEO Scholars is notably higher than their public school peers in both subjects across all grade levels.
- More than three-fourths of CEO Scholars in grade 8 are achieving in ELA.
- More than nine out of 10 CEO Scholars in grade 8 are achieving in math.
- Average Bridgeport public school spending is more than twice the average tuition of private schools CEO Scholars attend.









Hartford: CEO Scholars & Public School Students, Achievement Compared, 2015-16

- The performance of Hartford CEO Scholars is higher than their public school peers except:
 - o Fourth grade CEO Scholars and their public school peers (all) tie with a 42 percent ELA achievement rate.
 - o Third grade CEO Scholars and their public school peers (all) tie with a 34 percent math achievement rate.
- Fifth grade onward, ELA and math achievement rates for CEO Scholars are notably higher.
- Average Hartford public school spending is more than three and a half times higher than the average tuition of private schools CEO Scholars attend.









New Haven CEO Scholars & Public School Students, Achievement Compared, 2015-16

- The performance of New Haven CEO Scholars is higher than their public school peers except:
 - o Third grade CEO Scholars have slightly lower math achievement than their public school peers (all).
 - o Fourth grade CEO Scholars have lower ELA and math achievement than their public school peers (all).
- Fifth grade onward, ELA and math achievement rates for CEO Scholars are higher.
- Average New Haven public school spending is more than three times higher than the average tuition of private schools CEO Scholars attend.










CEO Scholars' School Grades

• CEO Scholars' school grades across subjects and grade levels are well above average, overall in the mid- to high 80s, which is roughly equivalent to a letter grade of B or B+.

- Grades are presented as numbers according to the following general grading scale: A, 90-100; B, 80-89; C, 70-79; D, 60-69; and F, 59 and below.
- No New Haven private school enrolled and/or graded CEO Scholars in first grade.
- The single St. Mary's (New Haven) 8th grade ELA grade of 0 was excluded because it was likely an error; however, this exclusion does not materially
 affect the city or combined grade averages.
- Grades for 234 CEO Scholars were provided: 111 from Bridgeport; 56 from Hartford; and 67 from New Haven.

CEO Scholars with Standardized Test Scores by School and Grade Levels, 2015-16

- Private schools use a variety of standardized tests to measure student performance in ELA and math in most grades.
- 31 private schools attended by CEO Scholars administered standardized tests.
- 202 CEO Scholars were tested, and results were reported for 195 of them (96.5 percent).
- CEO funding for these students totaled \$393,155 in scholarships averaging \$2,063 each.
- Tuition at private schools attended by these CEO Scholars averaged \$5,020.

CEO Scholars with School Grades by School and Grade Levels, 2015-16

- Thirty private schools enrolling CEO Scholars issue grades based on a numerical scale.
- 234 CEO Scholars were graded in ELA and math.
- CEO funding for these students totaled \$473,027 in scholarships averaging \$2,049 each.
- Tuition at private schools attended by these CEO Scholars averaged \$5,280.
